Food Vendor Event Rules & Regulations

All spaces are First Come-First Serve basis. Payment in full received holds your reservation.
Final reservation deadline September 1st, 2006

1. **No space will be assigned without payment in full and a resale license. Contact State Board of Equalization for one day permits. Food Vendors must have an event permit from the Madera County Environmental Health Department - 675-7823.**
2. Space setup: Fri.: 5 pm – 11 pm - Sat. 6 am - 8:30 am. **Vehicles must be out of selling area Saturday before 9 am.**
3. **Sell only what is listed on your contract, unless pre-approved by Wild Wonderful Women, Inc.**
4. All health, fire, safety and any other law or event regulations applicable to use of such space must be abided by. No generators allowed, unless pre-approved. Sellers must clean their area before leaving. VIOLATORS will lose the right to attend the future fairs.
5. Wild Wonderful Women, Inc. retains the right to reject any seller at any time. Seller's use of space must be in compliance with Federal, State and Madera County laws in addition to event rules.
6. This contract is based on availability of the use of the Golden Oak Drive location. In the event of any land area modification not in the control of the sponsor or its contractor, the sponsor reserves the right to alter this contract in the area of space location and size. Vendor will be notified of any changes.
7. **Event is rain or shine.** In the event the show is canceled, Wild Wonderful Women, Inc. will be responsible to refund prepaid space fee and has no other liabilities with regard to this event.
8. Vendor Cancellations must be 30 days prior to show date. A \$25 cancellation processing fee will be deducted from your refund and will remain with Wild Wonderful Women, Inc.
9. Sellers are required to provide their own canopies/tents, tables, chairs, trash receptacle, and to take all their trash with them.
10. Upon signing the reservation contract the Seller agrees to all the rules above and assumes all liability for any loss or injury resulting while at this event on property or acts of god. Seller agrees to hold Wild Wonderful Women, Inc. its agents and property owners free from any liability. Seller is responsible and liable for his or her own merchandise, helpers and equipment.
